Ireland Legalizes Abortion: May 26, 2018

Irish voters have voted to overturn the nation’s legal protections for unborn children — setting up government-sponsored legislation to legalize abortions on babies as old as 6 months. After initial exit polling data showed an overwhelming defeat for pro-life campaigners hoping to keep the nation’s pro-life law in place the official tally of votes reveals Ireland has voted decisively to legalize abortions.

For decades, the Eighth Amendment has protected unborn babies and mothers equally in Ireland by recognizing that both are valuable human beings who deserve a right to life. More than 100,000 Irish unborn babies and mothers have been spared from the pain and death of abortion, thanks to the constitutional protection. Ireland has become one of the safest places in the world for pregnant mothers and their babies, with one of the lowest maternal mortality rates in the world

Hobby Lobby opens in Bellingham



Hobby Lobby stood up to govt. mandates stating they HAD to provide birth control to their employees! The Supreme Court granted them victory to practice their religious convictions!

Hobby Lobby History....JUNE 2014:

The Supreme Court granted a landmark victory for religious liberty, ruling that individuals do not lose their religious freedom when they open a family business. The court ruled 5-4 in favor of **David and**

Barbara Green and their family business, **Hobby Lobby**

ruling they do not have to violate their faith or pay severe fines.

At issue in [Burwell v. Hobby Lobby](#) (previously Sebelius v. Hobby Lobby Stores), is the Health and Human Service (HHS) Mandate which would have required David and Barbara Green and their family business Hobby Lobby to provide and facilitate four potentially life-terminating drugs and devices in their health insurance plan, against their religious convictions, or pay severe fines. [The Greens argued](#) that the mandate substantially burdened their religious beliefs in violation of a federal law the Religious Freedom Restoration Act!

Supreme Court Rejects Planned Parenthood Challenge to Arkansas Pro-Life Law May 29, 2018

The pro-life movement received a victory today as the Supreme Court rejected a Planned Parenthood legal challenge to an Arkansas pro-life law that could close two abortion clinics. After a federal appeals court turned back Planned Parenthood's legal challenge, [the Supreme Court did so today](#).

The Supreme Court on Tuesday left in place an Arkansas law that restricts medication-induced abortions, refusing to hear a challenge brought by Planned Parenthood. The court refused to hear the case without providing an explanation. Planned Parenthood of Arkansas and Eastern Oklahoma had challenged the law, and compared it to a measure in Texas struck down by the Supreme Court in 2016.

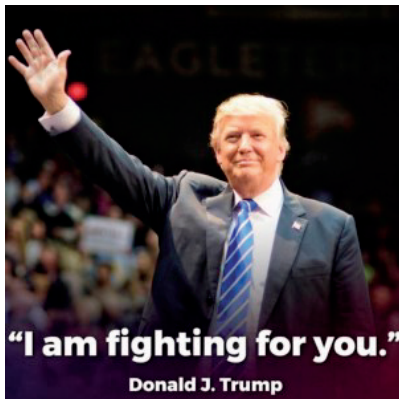
